As we informed you last week, all regularly attending Vendors are required to hold a City of Oceanside Business License. We have prepared this information to assist you with your application process with the City of Oceanside.

If you RESIDE IN Oceanside and DO NOT have a store front or commercial business location, you are considered an **IN-CITY HOME BASED BUSINESS**.

To assist you, we have attached a SAMPLE COPY of the Business License application you will use when you apply for your License. We have highlighted ALL the areas you are to complete in **YELLOW**. Do not complete any section not highlighted.

You must complete the sections that we have labeled on our sample application as “A”, “B”, “C” and “D”.

We are also attaching a blank application for you to complete. The cost for the Business License for your first year is \$54.00 (just over \$1.03 per market date)

Please complete your application and payment and deliver it to the City of Oceanside offices located at 300 N. Coast Highway. If paying by check, make payable to the “City of Oceanside”.

Note: The Business License Department is located on Ditmar Street, mid block between Pier View Way and Civic Center Drive – just 2 blocks from the Sunset Market Venue. They are open Monday thru Friday 8am – 5pm. You can stop by their offices on the way to the Market or it is an easy walk from our venue.

To assist anyone who needs help with this process, the City will have a representative at the Sunset Market you can meet with on 5/17/18 between the hours of 3:00 – 5:00pm. Please let us know in advance if you want assistance.

Please be advised, the City has provided us a window of time to complete this process by Thursday, May 24, 2018. Vendors must have a License by this date to continue vending in the Sunset Market.

On October 11, 2017, Governor Brown signed AB-1379. This bill raised the SB-1186 fee to \$4.00 for six years, effective January 1, 2018. The fee returns to \$1.00 after the six year period.

On September 19, 2012, Governor Brown signed into law SB-1186 which adds a state fee of \$1 on any applicant for a local business license or similar instrument or permit, or renewal thereof. The purpose is to increase disability access and compliance with construction-related accessibility requirements and to develop educational resources for businesses in order to facilitate compliance with federal and state disability laws, as specified.

Under federal and state law, compliance with disability access laws is a serious and significant responsibility that applies to all California building owners and tenants with buildings open to the public. HOME OCCUPATION REGULATION AGREEMENT

City of Oceanside
Financial Services Department

A. Permit Required: A home occupation in an A, O, MHP or R district shall require a business license, obtain by filing a completed application form with the Business License Office. A permit shall be issued upon determining that the proposed home occupation complies with the requirements of this section.

B. Contents of Application: An application for a home license shall contain:

- The name, address, and telephone number of the applicant.
- A completed description of the proposed home occupation, including amount and location of floor space occupied, provision for storage of materials, number and type of vehicles used, and provisions for parking.

C. Required Conditions and Regulations for a Home Occupation:

1. A home occupation shall be conducted entirely within a building (which the exception of a Horticulture Limited use), and the combination of the office, workspace and storage space shall occupy no more than 400 square feet of floor area (with the storage space not the exceed 200 square feet of floor area). No outdoor storage, or storage in required garage parking areas, shall be permitted. The amount and type of flammable, hazardous or toxic materials stored on-site, in conjunction with a home occupation, shall not be in excess of the amount normally found in the district.
2. The existence of a home occupation shall not be apparent beyond the boundaries of the site. No use shall create noise, dust, vibration, smell, smoke, glare, electrical interference, fire hazard, or other hazard or nuisance to any greater or more frequent extent than that usually experienced in a district under the circumstances where no home occupation exist. All noise shall comply with the City's Noise Control Ordinance (Chapter 38 of the Code of the City of Oceanside)
3. No signage shall be permitted.
4. No one other than the resident of the dwelling shall be employed on-site or report to work at the site in the conduct of a home occupation. This prohibition also applies to independent contractors.
5. No kilns exceeding 10 cubic feet in size shall be permitted, and a home occupation shall comply with the performance standard prescribed by Section 3026.

6. No more than one truck with the maximum capacity of one ton incidental to a home occupation shall be kept on the site. No signage identifying the existence of the home occupation shall be permitted on the vehicle.
7. The number of parking spaces available to a dwelling unit housing a home occupation shall not be reduced to less than two. At the minimum, a two-car garage with minimum dimensions of 20 feet by 19 feet shall be provided for the parking of vehicles (two 10-foot by 19-foot parking spaces). Materials and goods shall not be stored, and no permanent work area work bench or structures shall be built, within the required garage parking area.
8. A home occupation shall not create pedestrian, automobile, or truck traffic in excess of the normal amount in the district.
9. The delivery of materials, goods, or products to and from the location of a home occupation shall be limited to the hours of 7:00 am. to 7:00 pm., with the exception of newspaper deliveries.
10. The size of delivery vehicles used in conjunction with the delivery of materials, goods, or products to and from the location of a home occupation shall be limited to a single unit truck with a maximum of 28-foot length and a maximum gross vehicles weight of 24,000 pounds.
11. No motor vehicle repair, beauty shop, barber shop, retail sales or any regulated use shall be permitted. A home occupation shall not include any space open to multiple business visitors, customers, or clients, and there shall be no advertising of the address of the home occupation that results in attracting persons to the premises.

The license for a home occupation that is not operated in compliance with these regulations shall be revoked by the Business License Inspector, with the concurrence of the Building Director and the City Manager after 30 days written notice unless the home occupation is altered to comply.

I have read and understand the “Home Occupation Regulations” and agree to comply with all the regulations as stated. I understand that the Business License is subject to revocation if any of the “Home Occupation Regulations” are violated.

10. The size of delivery vehicles used in conjunction with the delivery of materials, goods, or products to and from the location of a home occupation shall be limited to a single unit truck with a maximum of 28-foot length and a maximum gross vehicles weight of 24,000 pounds.
11. No motor vehicle repair, beauty shop, barber shop, retail sales or any regulated use shall be permitted. A home occupation shall not include any space open to multiple business visitors, customers, or clients, and there shall be no advertising of the address of the home occupation that results in attracting persons to the premises.

The license for a home occupation that is not operated in compliance with these regulations shall be revoked by the Business License Inspector, with the concurrence of the Building Director and the City Manager after 30 days written notice unless the home occupation is altered to comply.
